**AN ORDINANCE TO AMEND THE 2018
DEPARTMENT OF PARKS AND RECREATION
BUDGET FOR ELECTRICITY AT THE ELY
PARK GOLF COURSE**

WHEREAS, the Commissioner of Parks & Recreation and Comptroller of the City of Binghamton find it proper and necessary to amend the 2018 Department of Parks and Recreation budget for electricity at the Ely Park Golf Course; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on October 31, 2018.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2018 Department of Parks and Recreation budget for electricity at the Ely Park Golf Course as follows:

- (i) \$6,000 increase to revenue budget line A.42770 (Unclassified)
- (ii) \$6,000 increase to appropriation budget line A7020.54202 (Electricity)

Section 2. That this ordinance shall take effect immediatly.
