AN ORDINANCE TO AMEND CHAPTER 124-44.A, PAYMENT SCHEDULE FOR HEALTH INSURANCE PREMIUMS, FOR OFFICERS AND EMPLOYEES NOT COVERED BY COLLECTIVE BARGAINING AGREEMENTS IN 2019

WHEREAS, the Council of the City of Binghamton wishes to amend the City Code Chapter 124, *Personnel Policies*, §124-44.A, *Health Insurance and Disability Benefits; Payment Schedule for Health Insurance Premiums*, to include the 2019 percentages for health insurance premiums.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Code of the City of Binghamton, Chapter 124, *Personnel Policies*, §124-44.A, *Health Insurance and Disability Benefits; Payment Schedule for Health Insurance Premiums*, is hereby amended to include the 2019 percentages for health insurance premiums to be paid by the City as follows: Traditional Plan 82%, PPO 83%, and High Deductible 85%.

Section 2. That this ordinance shall take effect immediately.
