**AN ORDINANCE AMENDING THE 2018
GENERAL FUND BUDGET TO PURCHASE
REAL PROPERTY AND PAY REAL PROPERTY
TAXES**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2018 General Fund budget to purchase real property and pay real property taxes; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on November 20, 2018.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2018 General Fund budget to purchase real property and pay real property taxes as follows:

Transfer From (Decrease):
\$118,500 A9015.58000 (Police & Fire Retirement)

Transfer To (Increase):
\$118,500 A1364.54681 (Taxes/Purchase of Real Property)

Section 2. That this ordinance shall take effect immediately.
