**AN ORDINANCE TO AMEND THE 2018
CAPITAL ENGINEERING BUDGET TO REPAIR
ROBINSON STREET STAIRS AND CREATE A
NEW EXPENSE BUDGET LINE**

WHEREAS, the City Engineer and Comptroller of the City of Binghamton find it proper and necessary to amend the 2018 Capital Engineering budget to repair Robinson Street stairs, create a new expense budget line for such, and to transfer funds thereto; and

WHEREAS, the cost of this project is not to exceed \$29,975; and

WHEREAS, funds are available for this purpose; and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on November 20, 2018.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2018 Capital Engineering budget to create a new expense budget line (TBD) for the Robinson St Stair Repair and transfer funds thereto as follows:

Transfer From (Decrease):

\$29,975 H1440.590032 (Bridge Improvements)

Transfer To (Increase):

\$29,975 H1440.(TBD)(Robinson St Stair Repair)

Section 2. That this ordinance shall take effect immediately.
