**AN ORDINANCE AMENDING THE 2018  
REFUSE DISPOSAL BUDGET TO DEFUND SR.  
STREET MAINTAINER AND ADD AN  
ADDITIONAL MOTOR EQUIPMENT  
OPERATOR**

WHEREAS, the Commissioner of the Department of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2018 Refuse Disposal budget to defund Sr. Street Maintainer at an annual salary of \$43,553 and add an additional Motor Equipment Operator at an annual salary of \$42,585; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 20, 2018.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2018 Refuse Disposal budget to defund Sr. Street Maintainer at an annual salary of \$43,553 and add an additional Motor Equipment Operator at an annual salary of \$42,585, and to transfer funds through the end of 2018 as follows:

Transfer From (defund/decrease):

\$4,258.49 CL8160.51000 (Per Serv-  
Sr. Street Maintainer)

Transfer To (fund/increase):

\$4,258.49 CL8160.51000 (Per Serv-Motor  
Equipment Operator)

Section 2. That this Ordinance shall take effect November 26.
