**AN ORDINANCE TO AMEND THE 2018
GENERAL FUND BUDGET TO TRANSFER
FUNDS TO REIMBURSE THE IT DEPARTMENT
FOR SOFTWARE PURCHASED FOR THE
PARKS DEPARTMENT**

WHEREAS, the Director of Information Technology and the Commissioner of the Department of Parks and Recreation find it proper and necessary to amend the 2018 general fund budget to transfer funds in the amount of \$18,500 from the Parks Department to the IT Department to reimburse for software purchased; and

WHEREAS, the transfer of funds was approved by the Board of Estimate and Apportionment on October 17, 2018.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2018 general fund budget to transfer funds in the amount of \$18,500 from the Parks Department to the IT Department to reimburse for software purchased as follows:

Transfer From (Decrease):

\$10,000 A7020.51800 (Temp Services)
8,500 A7140.51800 (Temp Services)

\$18,500

Transfer To Increase):

\$18,500 A1680.52300 (HW/SW)

\$18,500

Section 2. That this ordinance shall take effect immediately.
