AN ORDINANCE TO AMEND THE 2019
DEPARTMENT OF ECONOMIC
DEVELOPMENT BUDGET TO CONTINUE
FUNDING OF A TEMPORARY, PART-TIME
CLERICAL POSITION TO ASSIST IN THE
ADMINISTRATION OF THE FEMA BUYOUT
GRANT

WHEREAS, pursuant to Permanent Ordinance 18-68 dated August 22, 2018, the Council of the City of Binghamton approved a budget amendment to the 2018 Department of Economic Development to add a temporary, part-time clerical position to assist in the administration of the FEMA Buyout Grant; and

WHEREAS, the Director of Economic Development finds it proper and necessary to amend the 2019 Department of Economic Development budget to continue funding of a temporary, part-time clerical position to assist in the administration of the grant;

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on December 19, 2018.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Department of Economic Development budget to continue funding of a temporary, part-time clerical position and to transfer funds as follows:

Transfer From (Decrease):

Transfer To (Increase):
