**AN ORDINANCE AMENDING THE 2018
HOUSING BUDGET TO PROVIDE A
CORRECTION TO A RESPONSIBILITY
ADJUSTMENT IN THE DEPARTMENT OF
PLANNING, HOUSING & COMMUNITY
DEVELOPMENT**

WHEREAS, pursuant to Permanent Ordinance 18-66, dated August 22, 2018, the Council of the City of Binghamton approved a responsibility adjustment for the Program Assistant in the Department of Planning, Housing & Community Development; and

WHEREAS, the responsibility adjustment needs to be corrected through December 31, 2018; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 9, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:



Transfer From (Decrease):
\$324.38 A8668.51000 (Per Serv-Housing
Caseworker)

Transfer To (Increase):
\$324.38 A8668.51000 (Per Serv-Resp.
Adjust.-Program Assistant)

Section 2. That this ordinance shall take effect immediately.
