AN ORDINANCE AMENDING THE 2019
BUDGET FOR INCREASED EXPENDITURES
AND ANTICIPATED REVENUE FOR
INSTALLATION OF AN ELECTRIC VEHICLE
(EV) CHARGING STATION AND ASSOCIATED
NYSERDA REBATE

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 budget for increased expenditures and anticipated revenue for installation of an electric vehicle (EV) charging station and associated NYSERDA rebate; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 9, 2019.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 budget for increased expenditures and anticipated revenue for installation of an electric vehicle (EV) charging station and associated NYSERDA rebate as follows:

- i) \$8,000 increase to budget line A.43089 (State Aid-Other)
- ii) \$8,000 increase to budget line A1210.54610 (Building/Equip Improv & Maint)

Section 2. That this ordinance shall take effect immediately.
