AN ORDINANCE AMENDING THE 2019
FINANCE AND DEPARTMENT OF PUBLIC
WORKS BUDGET TO PROVIDE
RESPONSIBILITY ADJUSTMENTS TO
COMPENSATE FOR A VACANT POSITION

WHEREAS, the Council of the City of Binghamton adopted Permanent Ordinance O18-74, dated September 5, 2018, and Permanent Ordinance O18-120, dated December 5, 2018, in which the Finance Clerk was granted two responsibility adjustments in the total amount of \$972 for assumed responsibilities of the Senior Payroll Clerk in the Department of Public Works; and

WHEREAS, the position of Senior Payroll Clerk in the Department of Public Works continues to be vacant; and

WHEREAS, in 2019 the Finance Clerk and a Temporary Services Clerk will assume the responsibilities of the Senior Payroll Clerk during this vacancy; and

WHEREAS, the City wishes to compensate the Finance Clerk and Temporary Services Clerk an aggregate additional amount of \$17,202.46 for these assumed responsibilities through February of 2019; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 9, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Finance and Department of Public Works budget to compensate the Finance Clerk and Temporary Services Clerk an aggregate additional amount of \$17,202.46 for assuming the responsibilities of the Senior Payroll Clerk through February of 2019 as follows:
