**AN ORDINANCE AMENDING THE 2019 SNOW  
REMOVAL BUDGET TO CREATE AND FUND A  
NEW BUDGET LINE FOR TEMPORARY  
SERVICES**

WHEREAS, the Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 Snow Removal budget to create and fund a new budget line for temporary services; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 9, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Snow Removal budget to create budget line A5142.51800 (Temporary Serv.-CDL Drivers).


Section 2. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Snow Removal budget to fund this new budget line for temporary services as follows:

Transfer From (Decrease):  
\$10,000 A5142.51000 (Per Serv.-Snow  
Removal)

Transfer To (Increase):  
\$10,000 A5142.51800 (Temp Serv.-CDL  
Drivers)

Section 3. That this ordinance shall take effect immediately.
