AN ORDINANCE AMENDING THE 2019  
MAINTENANCE OF ROADS BUDGET TO  
DEFUND SR. STREET MAINTAINER AND ADD  
AN ADDITIONAL MOTOR EQUIPMENT  
OPERATOR

WHEREAS, the Acting Commissioner of the Department of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 Maintenance of Roads budget to defund Sr. Street Maintainer at an annual salary of \$43,553 and add an additional Motor Equipment Operator at an annual salary of \$42,585; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on February 6, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Maintenance of Roads budget to defund Sr. Street Maintainer at an annual salary of \$43,553 and add an additional Motor Equipment Operator at an annual salary of \$42,585, and to transfer funds accordingly as follows:

Transfer From (defund/decrease):

\$43,553 A5110.51000 (Per Serv-  
Sr. Street Maintainer)

Transfer To (add/fund/increase):

\$42,585 A5110.51000 (Per Serv-Motor  
Equipment Operator)  
968 A1990.55003 (Contingency-DPW)
