**AN ORDINANCE AUTHORIZING THE
CANCELLATION OF THE 2003 CITY OF
BINGHAMTON REAL PROPERTY TAXES IN
THE AMOUNT OF \$399.46 ON 93 MAIN STREET**

WHEREAS, the Corporation Counsel and Assessor of the City of Binghamton recommend cancellation of the 2003 City of Binghamton real property taxes in the amount of \$399.46 on 93 Main Street because the taxes are uncollectable based on environmental conditions; and

WHEREAS, cancellation of such taxes was approved by the Board of Estimate and Apportionment on February 6, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the 2003 City of Binghamton real property taxes in the amount of \$399.46 on 93 Main Street are hereby cancelled and any tax collecting authority related thereto is authorized to amend its records accordingly.

Section 2. That this ordinance shall take effect immediately.
