**AN ORDINANCE TO AMEND THE 2018
PARKING RAMPS BUDGET TO INCREASE THE
MANAGEMENT SERVICES BUDGET LINE FOR
DECEMBER EXPENSES**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2018 Parking Ramps Budget to increase the Management Services budget line for December expenses; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on February 6, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2018 Parking Ramps Budget to increase the Management Services budget line for December expenses as follows:

Transfer From (defund/decrease):

- \$23,644 CP5650.54202 (Electricity)
- 2,137 CP5650.54440 (Elevator Service & Repair)
- 790 CP5650.54112 (Gas/Diesel)
- 685 CP5650.54102 (Gen Operating Supplies)
- 250 CP5650.54142 (Traffic Safety Materials)
- 200 CP5650.54210 (Phone/Fax/Internet)
- 170 CP5650.54655 (Preventative Maintenance)

\$27,876

Transfer To (fund/increase):

- \$27,876 CP5650.54427 (Management Services)
