WHEREAS, the Comptroller finds it proper and necessary to amend the 2018 Community Development Budget for Commission on Architecture and Urban Design (CAUD) Board Member Service Fees for 2017 and 2018; and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on February 20, 2019.

\$400 A7010.54412 (Board Member Services)
