AN ORDINANCE AMENDING THE CODE OF
THE CITY OF BINGHAMTON CHAPTER 240,
FLOOD DAMAGE PREVENTION, SECTION 4,
ADMINISTRATION

WHEREAS, the Code of the City of Binghamton Chapter 240, *Flood Damage Prevention*, Section 4, *Administration* designates the local administrator for granting or denying permit applications; and

WHEREAS, the Director of Planning has recommended an amendment to Chapter 240, Section 4 to replace the Planning Commission with the Director of Planning as the local administrator.

NOW THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That Chapter 240, *Flood Damage Prevention*, Section 4, Administration of the Code of the City of Binghamton is hereby amended as follows:

§ 240-4. Administration [Amended 3-6-2019 by Ord. No 19-28]

- A. Designation of the local administrator. The Director of Planning is hereby appointed as the local administrator to administer and implement this chapter by granting or denying development permit applications in accordance with its provisions. [Last amended 3-6-2019 by Ord. No 19-28]

Section 2. That this ordinance shall take effect as of immediately.
