**AN ORDINANCE TO AMEND THE 2019
ENGINEERING AND DEPARTMENT OF
PUBLIC WORKS BUDGETS FOR TEMPORARY

WHEREAS, the Acting Commissioner of Public Works, City Engineer, and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 Engineering and Department of Public Works budgets for temporary services; and

WHEREAS, this budget transfer was approved by the Board of Estimate and Apportionment on March 6, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Engineering and DPW budgets for temporary services as follows:

Transfer From (Decrease):


\$7,650 A1490.51000 (Per Serv-Superintendent
