**AN ORDINANCE TO AMEND THE 2018
BUDGET TO TRANSFER FUNDS TO ACCRUE
FINAL PAYROLL IN 2019**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2018 budget to transfer funds to accrue final payroll in 2019; and


