**AN ORDINANCE TO AMEND THE 2019
BEACHES AND POOLS BUDGET TO CORRECT
THE HOURLY RATE FOR THE RECREATION
PARK POOL MANAGER**

WHEREAS, the Acting Commissioner of Parks & Recreation and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 Beaches and Pools budget to correct the hourly rate for the Recreation Park Pool Manager due to a drafting error; and

WHEREAS, such hourly rate should be listed at \$12.60 per hour, however, this correction does not increase the total budgeted amount of \$4,666.00; and


WHEREAS, this budget amendment was approved by the Board of Estimate and Apportionment on March 20, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Beaches and Pools budget, budget line A7180.51800 (Temp. Serv-Rec Park Pool Mgr) from \$12.35 per hour to \$12.60 per hour and this correction does not increase the total budgeted amount of \$4,666.00.

Section 2. That this ordinance shall take effect immediately.
