**AN ORDINANCE AMENDING THE 2019  
SEWER BUDGET TO FUND A LABORER  
POSITION**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2019 Sewer budget to fund a Laborer position; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on July 17, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Sewer budget to fund a Laborer position and to transfer funds as follows:

Transfer From (defund/decrease):

\$7,700 G8120.51000 (Per Serv-Waste Water Pump Maintainer)

Transfer To (fund/increase):

\$7,700 G8120.51000 (Per Serv-Laborer)

Section 2. That this Ordinance shall take effect immediately.
