**AN ORDINANCE TO AMEND THE 2020
SIGNAL/COMBINED SHOPS BUDGET FOR
THE DISPATCHER POSITION**

WHEREAS, the Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Signal/Combined budget for a transfer in funds to cover the Dispatcher position; and

WHEREAS, the current Dispatcher is retiring and money needs to be transferred in order to cover the position for the remainder of the year; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on February 19, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Signal/Combined budget for a transfer of funds to cover the Dispatcher position in the Department of Public works at \$22,000 from budget line A5110.51000 (DPW-St. Maintainer) to budget line A5110.51000 (DPW-Dispatcher).

Transfer From (defund/decrease):

\$22,000 A5110.51000 (DPW-St Maintainer)

Transfer To (fund/increase):

\$22,000 A5110.51000 (DPW-Dispatcher)

Section 2. That this Ordinance shall take effect immediately.
