**A RESOLUTION AUTHORIZING THE MAYOR
TO ACCEPT FUNDS FROM THE BROOME
COUNTY YOUTH BUREAU**

WHEREAS, the City of Binghamton is eligible to receive a grant in the amount of \$7,000 from the Broome County Youth Bureau; and

WHEREAS, the funds will be used towards 2018 Summer Playground Program expenses; and

WHEREAS, the grant does not require a local match; the grant funds will be administered by the Commissioner of the Department of Parks and Recreation, or her designee.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept the Broome County Youth Bureau's grant in the amount of \$7,000 to be used towards 2018 Summer Playground Program expenses; and be it further

RESOLVED that there is no City match for the acceptance of such funds; the Commissioner of the Department of Parks and Recreation, or her designee, shall be the grant project administrator.
