A RESOLUTION AUTHORIZING THE MAYOR  
TO ENTER INTO AN AGREEMENT WITH  
EMERGENCY SERVICES CONSULTING  
INTERNATIONAL (ESCI) TO CONDUCT A FIRE  
STATION CONSOLIDATION STUDY

WHEREAS, the City of Binghamton wishes to enter into an agreement with Emergency Services Consulting International (ESCI) to conduct a Fire Station Consolidation Study; and

WHEREAS, this agreement includes project initiation, baseline assessment and system analysis, future system-demand projections, consolidation comparisons, and development and final report; and

WHEREAS, the estimated cost for such services is not to exceed \$23,780.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Emergency Services Consulting International (ESCI) to conduct a Fire Station Consolidation Study, at a cost not to exceed \$23,780, and that funds will be deducted from budget line A3410.54410 (Professional Services) for this purpose.
