WHEREAS, the Binghamton Local Development Corporation ("BLDC") provides economic development services to the City of Binghamton as outlined in the Binghamton New York Community Development Block Grant ("CDBG") Program as approved by the City of Binghamton and the United States Department of Housing and Urban Development ("HUD"); and

WHEREAS, the City wishes to renew the agreement with the BLDC for use of Fiscal Year (FY) 44 CDBG funds in an amount not to exceed \$163,000 through December 31, 2019, as set forth in the attached Sub-Recipient Agreement.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE, that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the BLDC for economic development services for use of FY 44 CDBG funds in an amount not to exceed \$163,000 through December 31, 2019, as set forth in the attached Sub-Recipient Agreement, and that funds will be deducted from budget line CD6889.54000.CDY44 (Contractual) for this purpose.
