WHEREAS, the City of Binghamton wishes to enter into an agreement with FAMILY ENRICHMENT NETWORK, INC. for the use of Fiscal Year 44 HOME funding in the total amount of \$100,000 for a Homeless Housing Project at 31 Virgil Street.

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with FAMILY ENRICHMENT NETWORK, INC. for the use of Fiscal Year 44 HOME funds in the total amount of \$100,000 and that funds shall be deducted from budget line CE8689.533802.CEY44 (HOME CHDO) for this purpose.
