
WHEREAS, the City Engineer recommends the City enter into an agreement with GHD Consulting Services Inc. for professional engineering services and coordination assistance with the New York State Department of Health (NYS DOH) Lead Service Line Replacement Program; and

WHEREAS, the cost for such services is \$27,100 and funds are available for this purpose.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with GHD Consulting Services Inc. for professional engineering services and coordination assistance with NYS DOH Lead Service Line Replacement Program, at a cost not to exceed \$27,100, and funding shall be deducted from budget line H8340.555555.FX001 (Lead Service Line Replacement) for this purpose.
