
WHEREAS, the City Engineer recommends the City enter into a Professional Services agreement with Barton & Loguidice, DPC for mandatory USACOE/NYSDEC Pipe/Conduit Inspection and Maintenance work for the Binghamton Flood Control Project; and

WHEREAS, the cost for such services is \$48,850 and funds are available for this purpose.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into a Professional Services agreement, approved as to form and content by the Office of Corporation Counsel, with Barton & Loguidice, DPC for mandatory USACOE/NYSDEC Pipe/Conduit Inspection and Maintenance work for the Binghamton Flood Control Project, at a cost of \$48,850, and funding shall be deducted from budget line H1440.525324 (Flood Wall Pipe Inspect/Repair) for this purpose.
