A RESOLUTION AUTHORIZING THE MAYOR
TO AMEND THE CONTRACT WITH FAMILY
ENRICHMENT NETWORK (FEN) FOR
HOMELESS PREVENTION

WHEREAS, pursuant to Permanent Resolution 18-124, the City of Binghamton entered into a contract with Family Enrichment Network (FEN) for Homeless Prevention/Rapid Rehousing; and

WHEREAS, the City's financial contribution to this program was \$55,567; and

WHEREAS, the HUD Manager recommends amending said contract to increase funding by \$10,652.89 making the total contribution \$66,219.89; and

WHEREAS, the funding will be deducted from unspent Emergency Solutions funds to provide additional homeless prevention services targeting youth and adults being institutionally discharged.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to amend the contract, approved as to form and content by the Office of Corporation Counsel, with Family Enrichment Network (FEN) for Homeless Prevention/Rapid Rehousing, at a cost not to exceed \$66,219.89; and that funding will be deducted from budget line CG6142.533550.CGY44 (Program Funds) for this purpose.
