**A RESOLUTION AUTHORIZING THE MAYOR
TO ACCEPT A NYS DCJS 2020 LIVESCAN
GRANT PROGRAM LS20-1014-E00**

WHEREAS, the City of Binghamton is eligible for a NYS DCJS 2020 Livescan Equipment Grant Program LS20-1014-E00 in the amount of \$7,800 for purchasing new Livescan equipment at a total cost of \$15,600; and

WHEREAS, the Livescan Equipment Grant requires a local match of 50% of the total cost, the grant funds will be administered by the Chief of Police or his designee, the estimated start date is April 1, 2020, and the estimated date of completion is June 30, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept a NYS DCJS 2020 Livescan Equipment Grant Program LS20-1014-E00 in the amount of \$7,800 for purchasing new Livescan equipment, and be it further

RESOLVED that the local match in the amount of \$7,800 shall be deducted from budget line A1680.52300 (Hardware Software), the Chief of Police, or his designee, shall be the grant project administrator, and the estimated date of completion is June 30, 2021.
