SERVICE LINE REPLACEMENT PROJECT


WHEREAS, pursuant to Permanent Resolution 19-22, dated March 20, 2019, the City entered into an agreement with GHD Consulting Services, Inc. for professional engineering services and coordination assistance with the New York State Department of Health ("NYSDOH") Lead Service Line Replacement Program (the "Project"); and

WHEREAS, the City Engineer recommends the City enter into Supplemental No.1 Agreement with GHD Consulting Services, Inc. for additional services, including communication with NYSDOH regarding the LSLRP and inspection services, at a cost not to exceed \$14,200.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into Supplemental No.1 Agreement approved as to form and content by the Office of Corporation Counsel, with GHD Consulting Services, Inc. for the NYSDOH Lead Service Line Replacement Project at a cost not to exceed \$14,200; and funds shall be deducted from budget line H834.555555.FX001 (Moeller St. Pump ST. Study) for this purpose.
