**AN ORDINANCE TO AMEND THE 2023
GENERAL FUND BUDGET FOR ENGINEERING
PROFESSIONAL SERVICES**

WHEREAS, the City Engineer and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget for Engineering Professional Services in the amount of \$22,950; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on October 4, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget for Engineering Professional Services in the amount of \$22,950 as follows:

- (i) \$22,950 increase revenue budget line A.42401 (Interest and Earnings)
- (ii) \$22,950 increase expense budget line A1440.54410 (Eng. - Personal Services)

Section 2. That this Ordinance shall take effect immediately.
