AN ORDINANCE TO AMEND THE 2023 GENERAL FUND BUDGET FOR PARKS RELATED EXPENSES

WHEREAS, the Commissioner of Parks & Recreation and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget for Parks related expenses in the amount of \$48,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on October 18, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget for the Parks & Recreation Department Parks related expenses in the amount of \$48,000 as follows:

- (i) \$48,000 increase revenue budget line A.42401 (Interest and Earnings)
- (ii) \$48,000 increase expense budget line A7110.54640 (ParkRc Improv and Maint)

Section 2. That this Ordinance shall take effect immediately.
