**AN ORDINANCE TO SOLELY INCREASE THE
TOTAL COST OF THE CONLON FIELD TURF
PROJECT BUT NOT THE AMOUNT OF THE
BOND**

WHEREAS, the Council of the City of Binghamton (the "City"), in the County of Broome, New York, has heretofore duly authorized the issuance of bonds in the principal amount of not to exceed \$16,369,000 to finance various capital projects in and for the City, including the Conlon Field Turf Project, at an estimated maximum cost of \$2,250,000, all as specified in the bond Ordinance adopted on January 25, 2023; and

WHEREAS, the Council has now determined it appropriate and in the best interest of the City to amend said bond Ordinance adopted on January 25, 2023, to increase the total cost of the Conlon Field Turf Project to \$2,298,000, and it is necessary and in the public interest to increase the appropriation for such project by \$48,000; and

WHEREAS, the additional amount of \$48,000 will be funded through another source and not by the bond approved on January 25, 2023; and

WHEREAS, the City is notifying all interested parties, of this increase in the project cost of the Conlon Field Turf Project.

NOW, THEREFORE, be it resolved by the Council of the City of Binghamton, in the County of Broome, New York as follows:

Section 1. The City of Binghamton, in the County of Broome, New York (herein called the "City"), is hereby authorized to "amend" the bond approved on January 25, 2023, specifically the portion of that bond regarding the Conlon Field Turf Project, to reflect an increase in the total project cost of \$48,000 and to notify such parties of such bond increase.
