A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH WRF DESIGNS

WHEREAS, pursuant to Permanent Resolution 16-31, adopted February 3, 2016, the Council of the City of Binghamton accepted grant funds from the New York State Office of Parks, Recreation and Historic Preservation through the Environmental Protection Fund Municipal Grant Program to renovate and relocate the Ross Park Carousel; and

WHEREAS, the Mayor of the City of Binghamton wishes to enter into an agreement with WRF Designs for restoration of the Ross Park Carousel rides and supportive pieces, in an amount not to exceed \$426,000; and

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with WRF Designs, in an amount not to exceed \$426,000; and that funds shall be deducted from budget line H7110.555555.PK010 (Ross Pk. Reloc/Reno) for this purpose.
