AN ORDINANCE TO AMEND THE 2023
COMMUNITY DEVELOPMENT BLOCK
GRANT (CDBG) BUDGET FOR
HOMEOWNERSHIP/REHAB TO ADJUST FOR
THE HUD PROGRAM INCOME
RECONCILIATION

WHEREAS, the HUD Manager and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 CDBG budget for Homeownership/Rehab to adjust for the Housing and Urban Development (HUD) program income reconciliation to account; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 15, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 CDBG budget for Homeownership/Rehab to adjust for the Housing and Urban Development (HUD) program income reconciliation as follows:

- (i) \$85,914.34 decrease revenue budget line CD.42170.CDY48 (Comm. Dev. Income)
- (ii) \$85,914.34 decrease expense budget line CD8668.533509.CDY48
(Homeownership/Rehab)

Section 2. That this ordinance shall take effect immediately.


