AN ORDINANCE TO AMEND THE 2023
GENERAL FUND BUDGET FOR THE FIRE
DEPARTMENT TO PURCHASE FIRE GEAR

WHEREAS, the Fire Chief and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget to purchase fire gear for new Probationary Firefighters in the amount of \$25,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 15, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget for the Fire Department to purchase fire gear for new Probationary Firefighters in the amount of \$25,000 as follows:

Transfer From (Decrease):

\$25,000 A3410.51000 (Per Svcs - FF)

Transfer To (Increase):

\$25,000 A3410.54190 (Uniforms)

Section 2. That this Ordinance shall take effect immediately.
