**AN ORDINANCE TO AMEND THE 2023  
GENERAL FUND BUDGET FOR PARKS &  
RECREATION DEPARTMENT FOR  
INCREASED CHLORINE COSTS**

WHEREAS, the Commissioner of Parks & Recreation and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Budget for Parks & Recreation Department for increased Chlorine costs in the amount of \$17,736; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 15, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget for the Parks & Recreation Department for increased Chlorine costs in the amount of \$17,736 as follows:
