A RESOLUTION TO ACCEPT THE OFFICE OF JUSTICE PROGRAMS PATRICK LEAHY BULLETPROOF VEST GRANT

WHEREAS, the City of Binghamton is eligible to receive a Bulletproof Vest Grant in the amount of \$17,425 from the Office of Justice Programs; and

WHEREAS, the grant will be used to supplement acquisition costs of bulletproof vests for the Binghamton Police Department; and

WHEREAS, the Grant requires a local City match of \$17,425 from budget line A3120.52600 (Equipment); the grant funds will be reimbursable, and the Grant will be administered by the Binghamton Police Department; and the anticipated date of completion is August 31, 2025.
