WHEREAS, the City of Binghamton is eligible for the Dick's Sporting Goods Foundation Sports Matters Program Grant in the amount of \$7,500 to be used for youth sports equipment and programs enhancements; and

WHEREAS, the Grant does not require local match; the grant funds will be upfront, and the Grant will be administered by the Commission of Parks & Recreation or his designee.

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept the Dick's Sporting Goods Foundation Sports Matters Program Grant for youth sports equipment and program enhancements in the amount of \$7,500; and that funds will be available in budget line A7110.555555.PK010 (Park&Rec - Grants) for this purpose.
