WHEREAS, the City of Binghamton is eligible for the Broome County Community Beautification and Environmental Stewardship Mini-Grant in the amount of \$2,500 and Broome County Economic Development and Marketing Grant in the amount of \$1,500 to be used for the design and printing of light pole banners to be installed in the City of Binghamton: and

WHEREAS, these Grants require no local match; the grant funds will be reimbursable, and the Grants will be administered by the Director of Economic Development or his/her designee; and the estimated date of completion will be November 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept the Broome County Community Beautification and Environmental Stewardship Mini-Grant in the amount of \$2,500 and Broome County Economic Development and Marketing Grant in the amount of \$1,500; and that funds will be available in budget line A6989.54742 (Promotions/Marketing) for this purpose.
