RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an amended agreement No. 2, approved as to form and content by the Office of Corporation Counsel, with GHD Consulting Services Inc. for the CSO-LTCP Post Construction Compliance Monitoring Program in an amount not to exceed \$11,000; and that the funds shall be deducted from budget line A1440.54420 (Technical Services) for this purpose.
