## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2023 WATER FUND BUDGET FOR ADDITIONAL CHEMICAL EXPENSES DUE TO INCREASED COSTS, AND ADDITIONAL OVERTIME EXPENSE

WHEREAS, the Water/Sewer Superintendent and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Water Fund budget for chemical expenses due to increased costs and additional overtime expense in the amount of \$100,000 and \$20,000, respectively; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 6, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Water Fund budget for the additional chemical costs in the amount of \$100,000 and additional overtime in the amount of \$20,000 as follows:

- (i) \$100,000 increase expense budget line FX8330.54150 (Chemicals)
- (ii) \$ 12,000 increase expense budget line FX8330.51900 (Overtime)
- (iii) \$ 48,000 decrease expense budget line FX8340.51000 (Pers. Svcs Wtr Sys Maint)
- (iv) \$ 30,000 decrease expense budget line FX9060.58000C (Health Insurance)
- (v) \$ 25,000 decrease expense budget line FX1990.55000 (Contingency)
- (vi) \$ 17,000 decrease expense budget line FX8330.51000 (Personal Svcs Lab Tech)
- (vii) \$ 8,000 increase expense budget line FX8340.51900 (Overtime)

Section 2. That this Ordinance shall take effect immediately.
