AN ORDINANCE TO AMEND THE 2023 BUDGET FOR DEMOLITION OF A FIRE-DAMAGED PROPERTY AT 32 SECOND STREET

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 budget for demolition of a fire-damaged building at 32 Second Street, Binghamton, New York, Tax Parcel No. 160.60-2-13, in the amount of \$24,200; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 6, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 budget for demolition of a fire-damaged building at 32 Second Street in the amount of \$24,200 as follows:

- (i) \$24,200 increase expense budget line M1910.54470 (Demolition)
- (ii) \$24,200 increase revenue budget line M.42680 (Insurance Recoveries)

Section 2. That this Ordinance shall take effect immediately.
