AN ORDINANCE TO AMEND THE 2023 GENERAL FUND BUDGET FOR INCREASED RETIREMENT COSTS

WHEREAS, the Deputy Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget due to increased retirement costs in the amount of \$69,041; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 13, 2023.
