**AN ORDINANCE TO AMEND THE 2023
GENERAL FUND BUDGET FOR INCREASED
RETIREMENT COSTS**

WHEREAS, the Deputy Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget due to increased retirement costs in the amount of \$69,041; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 13, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget due to increased retirement costs in the amount of \$69,041 as follows:

Transfer From (Decrease):

\$69,041 A3120.51000 (Per Svcs - Police)

Transfer To (Increase):


\$54,486 A9010.58000A (ERS Retirement)

\$14,555 A9015.58000 (Pers Retirement)

\$69,041

Section 2. That this Ordinance shall take effect immediately.
