ORDINANCE

AN ORDINANCE TO AMEND THE 2023
GENERAL FUND BUDGET FOR INCREASED
ELECTRICITY AND STREET LIGHT EXPENSE

WHEREAS, the Deputy Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget due to increased electricity and street light expense in the amount of \$175,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 20, 2023.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget due to increased electricity and street light expense in the amount of \$175,000 as follows:

- (i) \$ 6,000 decrease expense budget line A1620.54202 (Electricity)
- (ii) \$ 5,000 decrease expense budget line A1650.54202 (Electricity)
- (iii) \$165,000 increase expense budget line A5182.54202 (Street Lights)
- (iv) \$ 10,000 increase expense budget line A8410.54202 (Electricity)
- (v) \$ 25,000 increase revenue budget line A.41240 (Comptroller Fees)
- (vi) \$139,000 increase revenue budget line A.42401 (Interest)

Section 2. That this Ordinance shall take effect immediately.
