AN ORDINANCE TO AMEND THE 2023  
GENERAL FUND BUDGET FOR THE  
ECONOMIC DEVELOPMENT DEPARTMENT  
TO ACCOUNT FOR YEAR-END EXTRA WEEK  
OF PAYROLL ACCRUAL

WHEREAS, the Director of Economic Development and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget for the Economic Development Department to account for year-end extra week of payroll accrual in the amount of \$800; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 20, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget for the Economic Development Department to account for year-end extra week of payroll accrual in the amount of \$800 as follows:

Transfer From (Decrease):


\$ 400 A6989.54101 (Office Supplies)

\$ 800

Transfer To (Increase):

\$ 800 A6989.51000 (Pers Svcs - ED)
