AN ORDINANCE TO AMEND THE 2023 HOUSING & URBAN DEVELOPMENT ADMINISTRATION AND HOUSING BUDGET FOR LEGAL ADS AND ADVERTISING EXPENSE

WHEREAS, the Director of Planning, Housing and Historic Preservation and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Housing and Urban Development and Housing budget for legal advertisements and advertising in the amount of \$1,665.04; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 20, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
