AN ORDINANCE TO AMEND THE 2023 GENERAL FUND BUDGET FOR VARIOUS OVER-BUDGET LINE ITEMS AT YEAR-END

WHEREAS, the Deputy Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget to account for various over-budget line items at year-end in the amount of \$150,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 20, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget for various over-budget line items at year-end in the amount of \$150,000 as follows:
