AN ORDINANCE TO AMEND THE 2023  
GENERAL FUND BUDGET TO ACCEPT THE  
FOURTH ROUND OF THE NYS HEALTHCARE  
WORKERS BONUS FOR PERSONAL SERVICES  
FOR THE FIRE DEPARTMENT

WHEREAS, the Fire Chief and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund budget for the Fire Department to accept the fourth round of the New York State Health Care Workers Bonus in the amount of \$17,762.25; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 20, 2023.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund budget for the Fire Department to accept the fourth round of the New York State Health Care Workers Bonus in the amount of \$17,762.25 as follows:

- (i) \$ 16,500.00 increase expense budget line A3410.51000 (Personal Services)
- (ii) \$ 1,262.25 increase expense budget line A9030.58000B (Social Security)
- (iii) \$ 17,762.25 increase revenue budget line A.43098 (State Aid-Other Public Safety)

Section 2. That this Ordinance shall take effect immediately.
